Based on the recognition accorded by National Council of Teacher Education, New Delhi, the University has accorded approval for grant of extension of Provisional Affiliation to Adarsh College of Teacher Education, Malleboinpally (Vill & Post), Jadcherla (Mdl), Mahabubnagar Dist. under the Mahabubnagar Educational Society, Plot, No. 7-5-51/C, Venkateshwara Colony Road, Mahabubnagar for the Academic Year 2021-22 to offer B.Ed. Course with an annual intake of 50 Subject to the fulfillment of the following conditions and general rules of affiliation.

1. Principal with Ph.D. to be appointed.
2. Rs. 10,000 worth of Books is to be purchased.
3. Psychology lab is to be equipped with intelligence & personality tests.
4. Staff approval/renewal for 2021-22.
5. 3 Governing Body meetings are to be conducted every Academic year including University nominee.

Therefore, the management is directed to submit the Compliance Report on the fulfillment of the above conditions on or before 25.08.2022 with documentary evidence wherever necessary, through Governing Body member nominated by the University in the following prescribed proforma.

GENERAL CONDITIONS TO BE FULFILLED BY ALL COURSES

1. That they should appoint teaching staff @ 1:12 through duly constituted selection Committee as per P.U. norms, associating the University Nominee on the selection Committee and Subject Expert representing all Methodologies and obtain the Renewal/Approval of the Registrar, Palamuru University for the Non-ratified staff at the beginning of the academic year whenever required.

2. They should run the course in two sections of (50) each where the accommodation for (100) students are not available.
3. To provide spacious rooms for classes and laboratories and separate toilets for Men and Women as suggested by the Inspection Committee.
4. Consolidated attendance statement is to be prepared every year and submit to the University.
5. It is made clear to all the colleges that Non fulfillment of the above conditions are not fulfilled by the College(s) within the stipulated time, such college(s) will be disaffiliated after intimation to NCTE /State Government.
6. To appoint a qualified librarian.
7. Attendance register and teaching diaries are to be maintained properly. Attendance of the students to be marked in the class room only.
8. Colleges should strictly adhere to Palamuru University almanac.
