ORDER:

In the references read above, the Administrative Officer, Telangana Admission and Fee Regulatory Committee (TAFRC), Hyderabad has informed that the Telangana Admission and Fee Regulatory Committee (TAFRC) meeting held on 15.10.2022 and recommended the tuition fee fixed for B.Ed M.Ed., U.G.D.P.Ed., B.P.Ed and M.P.Ed Courses for the Block Period 2022-25 based on the Audited Report submitted by the Colleges and the procedure followed in the last two Block Periods indicated at Annexures I to V, and recommendation of tuition fee does not include special fee and requested to issue order notifying the fee structure for the above said courses.

2. Government after careful examination have decided to accept the recommendations of the Telangana Admission and Fee Regulatory Committee (TAFRC) and the following notification shall be published in the issue of the Telangana Gazette.

NOTIFICATION

In exercise of the powers conferred by section 3 and 15 of the Telangana Educational Institutions (Regulation of Admission and Prohibition Capitation Fee) Act,1983 (TS Act 5 of 1983) read with sub rule (v) of Rule 4 of G.O.Ms.No.6, Higher Education (EC.2) Department, dtd.08.01.2007 and in pursuance of the recommendation of the Committee (Admission and Fee regulatory Committee) in their meeting held on 15.10.2022 the Governor of Telangana State hereby notify the following fee structure for the Courses of B.Ed M.Ed., U.G.D.P.Ed., B.P.Ed and M.P.Ed Courses in Private Un-Aided Institutions including Minority Institutions in the Telangana State for the block period 2022-2025:

- i) The Tuition Fee fixed for the Block Period 2022 - 2025 for B.Ed M.Ed., U.G.D.P.Ed., B.P.Ed and M.P.Ed Courses is enclosed as Annexure I to V.
- ii) The following directions are also given to the concerned Private Un-

- b) The Institutions shall not charge any Capitation Fee or any amount unauthorized or illegally under any other head or guise (e.g., donation etc.), either directly or indirectly, other than the Fee fixed by the Committee, as collection of any such unauthorized amounts would amount to charging of Capitation Fee, and that the surplus (profit) that is generated from the collection of the Fee must be for the benefit of the Institution, and cannot be diverted for other purposes or for personal gain.
- c) The Institutions are informed that fixation of the Fee Structure by the Committee will not by itself enable or permit the Managements to run the relevant Courses in their Institutions, if they are otherwise not duly recognized and permitted by the Government or NCTE /Concerned University etc. at any relevant time.
- d) The Fee, now recommended by the TAFRC for the Block Period 2022-2025, is based on the details/figures uploaded by the Institutions online and is subject to further physical verification. If it is found that any of the data given by the Institutions is not correct, the Fee shall be revised at a later date and these facts shall be informed to the University concerned and NCTE and relevant bodies for taking necessary action in accordance with law.
